**2012 DRYING PROGRAM CONTRACT**

This contract is made between United Farmers Cooperative and the undersigned.

Patron agrees to purchase the stated amount of propane at the price specified. Patron agrees to purchase the stated amount within the specified time period of 9/1/2012 to 11/25/2012. \*\*\* Patron is responsible for all contracted gallons\*\*\*

Any contract transfers to Livestock or Residential heating should be done by 12/01/2012.

This credit will show up on your January statement. This credit will be from the 20 cent per gallon down payment.
